Wedding Video Contract  
(This Contract consists of three pages)

Page 1

**Basic** - One camera and operator for the ceremony only, up to 1.5 hours, edited with client's music, titles, and credits. \$400

**Basic Plus** - One camera and operator for the ceremony and reception, up to 4 hours coverage, edited with client's music, titles, and credits. \$600

**Traditional** - Three cameras for the ceremony (two operators), one camera and operator at the reception. Pre-wedding coverage of wedding party (one camera coverage), interviews with family and friends at reception, up to 5 hours coverage, beginning one hour prior to the wedding, edited with client's music, titles, and credits. \$795

**Traditional Plus** - Traditional package plus rehearsal, up to one hour coverage. \$895

**Deluxe** - Traditional package plus rehearsal and dinner, up to 3 hours coverage. \$1095

**Extended Coverage** - If coverage exceeds the stated time, there will be an additional charge of \$35 per half hour per operator.

**Additional Operator** - \$75 per hour. Travel rates apply.

**Travel Time** - Time spent traveling to rehearsal dinner/reception is included in the coverage agreement.

**Travel Rates** - There will be an additional charge for travel beyond 25 miles from Baytown, Texas.

**Memories Video "Slide Show"** - Scan pictures, \$2 each. Client provides pictures on CD in order of appearance, \$1 each. Set to client's music with title. Added to wedding video at no charge. If produced separately, add \$25 (this charge waived if cost exceeds \$100). Payment is due upon completion.

**Deposit** - *A \$200 deposit is required to reserve date. Deposit is non-refundable within 5 calendar days of event. Half of balance is due on the day of the event. Balance is due on delivery of video to client. (See page 2, Refunds)*

Prices are for up to a two hour edited video. If the edited length exceeds two hours, there will be a \$100 charge for the additional set of DVD discs. Client will be notified prior to publishing to discuss ways to reduce length, if desired.

Price includes 3 copies of wedding video. Additional copies of wedding video - \$15 for single disc, \$25 for two-disc set.

State sales tax on all billed services. Prices subject to change. Once deposit is received, rates are in effect. Allow 4-6 weeks for delivery.

## Conditions of Contract

**Service** - Bay Area Video Productions agrees to provide videography services as outlined above in a professional manner consistent with industry standards, and will provide the client with a completed video in a timely manner (4 - 8 weeks). Bay Area Video Productions will videotape and edit the video using its best judgement as to camera placement and content acquisition, and is not responsible for restrictions or limitations placed upon them by venue principles, officiants, or participants. Interviews of family and friends cannot be guaranteed if they refuse to participate.

**Refunds** - Payments are not refundable unless the event is postponed for reasons beyond the control of the client, and the event cannot be rescheduled by Bay Area Video Productions.

**Cancellation** - If the client fails to make payments as agreed upon (see Page 1, Deposit), this contract will be deemed cancelled by the client, and Bay Area Video Productions shall not be obligated to complete any part of the video production. Any payments made shall be forfeited by the client and retained by Bay Area Video Productions, and Bay Area Video Productions shall be relieved of any further obligations to the client.

**Liability** - In the event that Bay Area Video Productions cannot meet its obligations in this contract, its liability shall be limited to the refund of any payments. Client shall be held liable for any damage or injury to Bay Area Video Productions equipment or personnel caused by guests or participants.

**Copyrights** - All original and edited tapes and master copies are the property of and copyrighted by Bay Area Video Productions. Client is aware of and assumes responsibility for any copyrighted music or works used in the production of the video. Client grants permission to Bay Area Video Productions to use any part of the production for the purpose of a wedding video demo, and a models release shall be deemed granted for all persons appearing in the video.

**Miscellaneous expenses, meals and breaks** - Client shall be responsible for expenses related to parking, access to venue, or any other expense incurred by Bay Area Video Productions while on location. A reasonable amount of time shall be given to production personnel for breaks and meals. Client is aware that videotaping may not occur during this time. Client is responsible for keeping production personnel notified of special or unusual events that are to be videotaped.
